The City of Temecula Community Services Department - Arts and Culture Division, is pleased to provide free gallery spaces for local artists. If you are interested in exhibiting at a city gallery, please read the following information carefully and complete the application form.

Applications are accepted from April 1, 2024 through June 30, 2024

- ★ Exhibitions for each gallery space, i.e. the Temecula Valley Museum, The Merc, Ronald H. Roberts Library, and Temecula Civic and Welcome Center, are planned one year or more in advance.
- Because of the high volume of applications, the Board of Directors select and assign artists to a gallery space based on amount of art available and suitability. Preference will be given to those who have not exhibited in the last two years.
- → All exhibits are selected by members of the Temecula Valley Museum Board of Directors in order to provide the public with exposure to varieties of styles and mediums.
- All galleries are in public lobby areas of City facilities and therefore all exhibition content must be family-friendly. Artwork will not be accepted or displayed by the City if it includes nudity, violence, explicit language, or depicts discrimination based on race, color, national origin, ancestry, religion, age, gender, sexual orientation, disability, etc. The City reserves he right to exclude art from an exhibition.

Artist Statement Guide and Directions

In order to help our judges understand who you are, the content of your work, and your influences, feel free to use these bullets as a guideline. Please keep your Artist Statement to 8-10 sentences long (about 2 paragraphs).

- What are the key ideas, issues, struggles, goals within your work or studio practice?
- Thematic focus on work (goal, purpose, intention, exploration).
- Content of work (themes, ideas, subject matter).
- Influences (cultural, historical, theoretical, art historical, personal, biographical).
- Form of work (materials, processes, tradition of work e.g. abstract, figurative, etc.) Describe your process and what the work looks/sounds like, etc.

While writing your artist statement, it's helpful to keep these things in mind:

- Who is your audience? It helps to have someone in mind when you are creating.
- How can you clarify what your work is about, how can you make your work easier to understand?
- Remember, if you are unsure of what your work is about, your audience will be as well.

Visual Art Policy

The City recognizes that while there are many outstanding art pieces available for display, the City must choose art for the limited display area at City facilities. The City shall select the art to be displayed in City facilities on the basis of artistic merit, creative excellence, intellectual richness, as well as its contribution towards the spirit, goals and theme of the proposed exhibit. City facilities are not a public forum for the display of art and nothing contained in this policy is intended to be nor shall be construed as a policy establishing a public forum for the display of art at City facilities. The City reserves the right to cancel the exhibition/event at any time, with or without a statement of reasons. The City may rely upon the recommendations of art judges or art groups for recommendations of the art to be displayed at City facilities. In such cases the judges or art groups shall recommend several pieces for display from which the City may select the limited number of art pieces to be displayed. Art depicting specified anatomical areas and specified sexual activities as defined in Section 5.09.030 of the Temecula Municipal Code, or any of them, shall not be displayed in areas open to the public.

General Liability Waiver

I recognize and understand that officials, volunteers, and members of the City of Temecula Community Services Department will not accept any responsibility for the loss, damage, or theft of ART OR CRAFT ITEMS OR PERSONAL PROPERTY at the City of Temecula Galleries.
